

## Target Employers: OSHA's Aggressive New Standards July 26, 2012, 1-2:30 p.m. ET

For the last two years, the Occupational Safety and Health Administration has been moving aggressively to step up the number of workplace inspections, implement new rules and increase penalties against employers. Indeed, OSHA's proposed new "Illness and Injury Prevention Program ("I2P2"), which OSHA itself calls the most fundamental change to workplace-safety standards since passage of the OSH Act, is causing considerable anxiety among employers and employer groups. I2P2, alone would require employers to identify and correct all safety and health hazards in the workplace- even those not covered by a specific OSHA standard-and would apply to all employers. Some groups estimate that compliance costs alone would be \$3,000 per employee per year and I2P2 is just one of many new rules proposed or implemented by OSHA in the last two years. The workplace safety landscape is changing rapidly and employers must keep abreast of new standards and inspection regime or suffer the consequences.
