In addition to his restructuring practice, Dan is an experienced litigator who has practiced in state and federal courts in a variety of jurisdictions in cases involving issues of corporate law and distressed commercial situations.

Dan earned his J.D. from Villanova University Widger School of Law in 2012, where he was the recipient of the Dorothy Day Award for Pro Bono Service. He graduated from the University of Colorado at Boulder in 2008 with a B.A. in History.
